Traffic levels through Hatfield Peverel are already not sustainable particularly when there are closures on the A12 due to accidents. Without this the plan is not deliverable because of the effect it will have on those living and travelling on the B1019, B1018, A414, B1022 and other roads out of and within the District. The Parish Council is concerned that funding for the North Heybridge relief road will divert funding for a road from the B1019 to the A12. A road directly to the A12 would make more sense and current pinch points would not be exacerbated. Less infrastructure would be required if more houses were to be built within easy access of the Southminster/Wickford railway line
