On the west side of Mangapp Chase and on the north side of Green Lane there are a number of dwellings located outside the defined settlement boundary for which rural area policies apply. Within these dwellings there is opportunity for a limited amount of infilling to take place. These dwellings would be in a sustainable location to public transport and the services within Burnham on Crouch.

The Spatial Vision and Development Strategy allows for 330 houses as windfall allocations within the plan and 345 houses as rural allocations this latter figure has not been identified in the Plan and therefore 675 of the proposed dwellings to be built within the Plan period remain un-allocated. This represents 15% of the total allocation which does not demonstrate that the plan is either effective or provide flexibility.

As the Local Plan is vague about rural housing and does not identify where the 15% is going to be allocated it is not clear whether the Local Plan is going to be effective and that 15% of these dwellings will be deliverable.
