Cold Norton Parish Council also wish to comment on the proposals for a neighbouring settlement at North Fambridge, since in emergency situations there may be an impact on Cold Norton to provide a rest centre or other support and because both villages share much of the same infrastructure. North Fambridge shares the category of a small village and is not able to support significant enlargement due to the shape of the settlement and the constraints on the siting of new development due to a consideration of flood risk, transport connections and other basic infrastructure including sewerage. What facilities there are are located in the South of the village, near to the river, but viable new developments would presumably be at the northern end, perhaps beyond reasonable walking distance. We note also that the scale of the proposal for Fambridge is such that it would radically alter the character of the existing settlement which is in conflict with MDC's own Plan criteria.
