These representations refer to Land adjacent to Vicarage Court, Southminster. On behalf of our client, The Chelmsford Diocesan Board of Finance we broadly support policy S2 in principle insofar as it provides an opportunity for limited development on our clients land.

We are supportive of the Pre-Submission Local Development Plan and consider it to be sound. The allocation of 345 dwellings is accepted within the plan providing that the figure is accepted to be a minimum. Maldon, as a district with a significant concentration of rural settlements must ensure that an adequate level of housing can be allocated to support the rural economy. As a result of the specific geographic and demographic conditions within Maldon District it is recommended that the council welcome an allocation in excess of 345 dwellings to ensure that the plan proposals are sound, effective and in accordance with paragraphs 47 and 48 of the NPPF.

We await the Rural Allocations Development Plan Document to identify appropriate sites for development. The land adjacent to Vicarage Court, Southminster has previously been promoted by our client to accommodate small scale complimentary growth. We welcome the opportunity to be consulted on this document.
