Having lived in the Dengie Hundred for over 60 years I believe that I am able to justify my comments regarding the Local Development plans for Southminster, Burnham & North Fambridge.

The Dengie Hundred is on a Peninsula with two roads going to Burnham & Southminster. They are already far too over-crowded and are incapable of withstanding any future increase of traffic.

The huge volume of lorries now going ^{to and} from the Wind Turbine site is a case in point. Quiet country lanes are being destroyed, which will be exactly the same problem when building material is required. I have had to sit in traffic jams several times, which nobody wishes to do including all these new home owners, who would only make the problem worse.

The area is prone to flooding, and as the E.A. will not build up seawalls, N. Fambridge is at a greater risk now.

once all these houses have been built, who is actually going to want to live here? There are hardly any job opportunities, schools are over-crowded, GP surgeries full. The nearest super-markets are in Maldon & S. Woodham. With everyone to-ing & fro-ing the roads will be in a permanent state of gridlock.
