NORTH FAMBRIDGE HAS BEEN IDENTIFIED WITH A STRATEGIC ALLOCATION OF 75 HOUSES IN THE FIRST FIVE YEARS OF THE PLAN. THIS IS NOT DELIVERABLE, GIVEN THAT APPROXIMATELY £2.5 MILLION WILL NEED TO BE SPENT TO MITIGATE THE SURFACE WATER AND FOWL WATER PROBLEMS WHICH EXIST IN THE VILLAGE, AND SHOULD BE UNDERTAKEN BEFORE ANY FURTHER BUILDING CAN BE CONSIDERED. NORTH FAMBRIDGE SHOULD NOT BE TAKEN IN ISOLATION FROM THE REMAINING VILLAGES IN THE SECTION IDENTIFIED AS RURAL ALLOCATION BUT SHOULD BE AFFORDED THE SAME 15 YEAR TIME-FRAME.
