Chelmsford City Council welcomes the opportunity to comment on Maldon District Council's Pre-Submission Draft Local Development Plan (January 2014). Chelmsford City Council support a Maldon District LDP which meets housing growth needs based on the SNPP 2010 based figures. This approach does not leave a shortfall in housing needs that would need to be provided for elsewhere. It is noted that the Strategic Housing Market Assessment Update 2012 (SHMA) indicates a total housing requirement for around 687 units and 242 affordable housing units per annum. This is significantly different to the SNPP 2010 based figure. This suggests that there could be a significant under provision of affordable housing across the Plan period. It could also be argued that the overall housing requirement should be further increased to make any the shortfall in affordable housing supply. It is acknowledged that the evidence provided in the SHMA should not be viewed in isolation and that the SHMA figure should not be considered as a housing requirement. However, further clarification on this issue is necessary.
