Whilst we fully support Policy I2 which reflects the continued need for a hospital and recognises that a proposal for such a facility, with appropriate enabling development, may be acceptable (particularly on appropriate greenfield locations on the edge of Maldon), it is considered that specific reference should be made in the policy to civic or community facilities being provided as enabling development for the required healthcare facilities.

The co-location of such facilities represents sustainable development and is anticipated in the Council's Maldon Community Hospital and/ or Civic Hub Scoping Report which states that out-of-town greenfield sites would ideally incorporate a Civic Hub, which incorporates Council Offices and a retail element.

If civic or community facilities are not specifically included then the policy justification for such facilities in less central locations is diminished.
