The Ma59 proposal for a Local Wildlife Area at Mundon Furze is not positively prepared as it is not needed to meet any development or infrastructure requirement.

The proposed area is not justified, as Mundon parish challenges what legal or moral right Essex Wildlife Trust have to propose Mundon Furze without any liaison with the Parish Council.

The proposed area designation would not be able to demonstrate 'delivery partners who are signed up for it' as 'the landowner' has not been directly consulted.

The proposed wildlife area is not consistent with national policy, as there is no exact requirement within the national Planning Policy Framework for any such quota.

The proposal does not meet legal compliance for the following reasons:-

The Council has not met its own Statement of Community Involvement as there has been no attempt to contact 'the landowner'. The onus has been on 'the landowner' having noticed this proposal within a complex document predominantly dealing with new housing developments. It appears very under-hand and in direct conflict with National 'localism' policies.

It is questioned if a Sustainability Appraisal has been carried out on Mundon Furze, as it is highly debatable if the Parish Council could afford any potential future requirements for various management strategies.
