National Planning Policy states that new development should not increase flood risk elsewhere.

No-where within Maldon District Council's LDP Surface Water Drainage policy does it re-iterate this. All that is referred to is diverting surface water away from urban areas (page 31, 2.57), which could in all probability exacerbate existing problems for down-stream rural areas such as Mundon.

As expressed within Mundon Parish Council's Stage 1 representation, the ever increasing flooding issues in Mundon (at Lime Brook, at Mundon Wash, at New Hall Lane and also the Palepit Corner to Dead-Away Bridge to Lawling Hall Outfall ditch network) are proof of an already deteriorating situation. Unless planning policy acknowledges this, and obligates developers (especially for the South Maldon areas) to pay for infrastructure improvements, such as pumping stations at downstream sluices, the proposal is not positively prepared or justified. The current proposed Community Infrastructure Levy proposal does not cover this scenario in any way, therefore this lack of wording within the LDP makes the proposal entirely un-sustainable.

The lack of re-iteration of 'new development not increasing flood risk elsewhere' would suggest the proposal has not been positively prepared and is not consistent with national policy.
