Most of Nam Fambridge is built on a flood plain as mapped by the Environment Agency. The plain wraps around the only road in and out of the village, it also crosses the road.

A serious flood would block the villagers from either entering or leaving their homes and prevent emergency vehicles access to the possible sites of development.

The position of the village alongside the tidal River Crouch means in times of extreme high tides and heavy rain flooding is a real risk - this being so recently in Dec 2013 when the Environment Agency contacted the village with a view to evacuation.

The National Planning Policy Framework states (page 29) "Local plans should take account of climate change over the longer term, including factors such as flood risk coastal change, water supply and changes to biodiversity and landscape.

New development should be planned to avoid increased vulnerability to the range of impacts arising from climate change

Inappropriate development in areas at risk of flooding should be avoided by directing development away from areas at highest risk."

All of the above seems to have been ignored by Maldon District Council.

- Make major extensions to the sea wall defences eg. install: flood gates, emergency pumps, raise the sea wall height, a flood barrier at the Crouch (c.f. Wivenhoe) (this would also protect South Woodham Ferrers)

- replace or vastly improve the existing sewage system to cope with increased 'run off' water

Maldon District Council could completely solve this problem by choosing an alternate place to build properties that doesn't pose this significant "flood risk" and danger to life.
