FLOOD PLAIN NORTH FAMBRIDGE

Environment Agency maps for the flood plain indicate areas in which flooding may occur however when investigating this matter further the Environment Agency tells us that the flood line on the maps is only meant as a guide line and as with recent events this is more than evident water rarely stops on a line on a map where future development is likely to be placed.

Access in and out of North Fambridge is via Fambridge Road which passes directly through the flood plain if flooding occurs this will mean there is no way for residents to leave the village and for emergency services to gain entry, further development will increase the problem, because of this no development should take place as this would be unsustainable due to increased sea level rises predicted due to climate change this will cause the flood plain to increase not diminish.

In recent years I have received 3 severe flood warnings causing danger to life from the Environment Agency even though I do not live directly on the flood plain, 2 of which were received on consecutive days in December 2013, surely this needs serious consideration to take place.
