The plan is not sound as it does not demonstrate sound infrastructure planning.

The proposed 75 dwellings in addition to development at Burnham-on-Crouch will increase the traffic on the B1010, which is already known by Maldon District Council to be a hazardous stretch of road with higher than average recorded accidents involving death or serious injury.

Vehicles entering and exiting North Fambridge do so at a sharp bend in the B1010, which is within a short stretch of road between two bends.

The increased traffic entering and exiting the village would add to the already hazardous position.

Maldon District Council do not seem to have made any objective appraisal of the safety issues involved.
