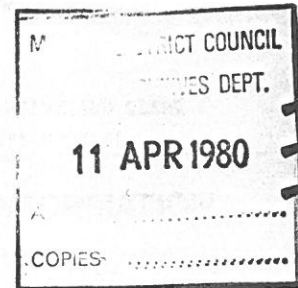

Direction Restricting Permitted Development at Braxted Park Farm, Witham
Direction No. 2/1980

NOTICE IS HEREBY GIVEN that the Essex County Council has made a Direction under Article 4 of the Town and Country Planning General Development Order 1977 directing that the permission given by Article 3 of the Order which permits the carrying out of engineering operations requisite for the use of land for the purposes of agriculture should not apply to the carrying out of such operations for the construction of reservoirs on certain land at Braxted Park Farm, Witham. The effect of the Direction is that engineering operations for the construction of reservoirs on that land may not be carried out unless permission is granted on a planning application in that behalf.

A copy of the Direction may be inspected at the offices of the Essex County Council, County Hall, Chelmsford during normal office hours.

N O W T H E R E F O R E the said Council in pursuance of the powers conferred upon them by Article 4 of the Town and Country Planning General Development Order 1977 hereby direct that the permission granted by Article 3 of the said Order shall not apply to development on the said land of the description set out in the Schedule hereto
