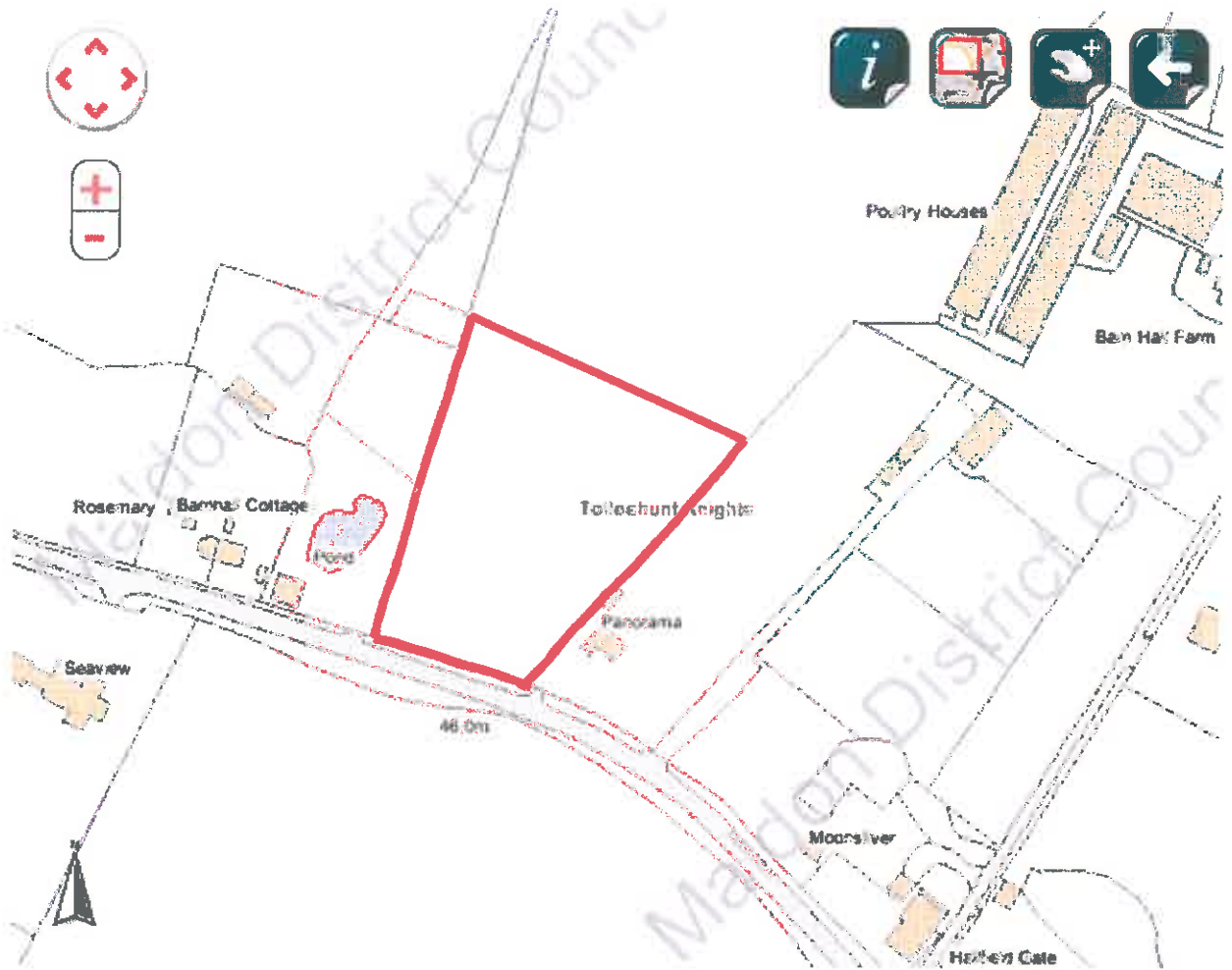
Q13 The Council has produced an updated Sustainability Appraisal to support the Draft LDP which is available on the Council's website. Do you have any comments on this? [Please use BLOCK CAPITALS]

The site is located to the north east of Barnhall Road and is situated to the west of Panorama. The site constitutes as an infill plot and could accommodate 1 or 2 dwellings. The development of this plot would be in keeping with the prevailing pattern of development in the locality and not detrimentally impact on the open countryside.

In terms of sustainability, it is important to note that in Paragraph 38 of the Appeal Statement APP/X1545/A/09/2112923, the Planning Inspector did not consider that the appeal site 'Restawyle' (which is located further east along Barnhall Road) is remote despite the site is some 4 or 5km from the nearest service and shopping centre at Tiptree and about 8km from Kelvedon where access can be gained to the A12. This is material consideration which should be taken into account when determining applications along Barnhall Road.

In addition to the above, the site would meet the requirements as contained within Paragraphs 47 and 49 of The National Planning Policy Framework in accordance with the Council's Development Plan Policies and the NPPF. The site is currently available, deliverable and would effectively contribute to the Maldon District current shortfall of housing sites.

Support the proposal to provide a village settlement boundary for Stow Maries. The site is within the centre of the village and currently comprises a series of out worn B2 commercial buildings and a former petrol station. A recent appeal examining a proposal for 8 units accepted the principal of residential development subject to the appropriate marketing of the commercial site.

The site is considered to be in a sustainable location as any development would be no further than the existing residential developments that are immediately adjacent to this site. Facilities and services are within walking distance from the site and bus services are available. The site could accommodate approximately 8 dwellings and would meet the requirements as contained within Paragraphs 47 and 49 of The National Planning Policy Framework. The site is currently available, deliverable and would effectively contribute to the Maldon District current shortfall of housing sites.

The Old Dairy, Broad Street Green, Heybridge

The settlement boundary should include the area edged in red as shown on plan attached with this questionnaire. The site is in two parts; a rectangular area comprising a former dairy and distribution centre now used as offices, and a triangular plot of scrub land located to the west. The site is occupied by JAP Contracts Ltd. Access and egress is via a long established roadway from Broad Street Green. The site is not within Flood Zones 2 or 3.

A considerable amount of infill development has been allowed by the Council in the past couple of years. The character of the area immediately in the vicinity of the site will therefore alter beyond recognition. The site is accessible by public transport. The site would meet the requirements as contained within Paragraphs 47 and 49 of The National Planning Policy Framework in accordance with the Council's Development Plan Policies and the NPPF. The site will be available from 2017, representing a suitable development during the latter stages of the Plan. It is otherwise deliverable and would effectively contribute to the Maldon District shortfall of housing sites.
